What kind of quotations should I choose to analyze?

Find passages or quotations that you think help us better understand the author's subject matter, characterizations, themes, symbols, or "big ideas"

Please don't just repeat what the quote says and/or summarize the scene or context. State the quote and then analyze its significance.

What format should I use?

See the attached double entry response journal template. This is the format I expect you to use for each entry. Use the left side of the column to copy down the significant quotes or passage from the novel with its page number. Use the right hand column to analyze its significance or make a connection. This can be typed or handwritten.

How many entries should I complete?

For each book, complete **four** significant quotes or passage analyses. Each analysis should be at least FIVE sentences, and interpret or analyze, not retell the plot. Your completed journal will have **EIGHT** entries.

The Double-Entry Journal: Choose

On The Left: The Quote	On The Right: Here you can write an analytical reflection about the quote or make a connection (text-to-text or text-to-self) to the quote
<p>Atticus, the lawyer, "was Maycomb County born and bred, he knew his people, they knew him, and because of Simon Finch's industry, Atticus was related by blood or marriage to nearly every family in the town" (6).</p> <p>*sometimes you may not want to include the entire quote to which you are referring, so instead you will use an ellipsis (...) to quote only the important part.</p> <p>For example: "When he was nearly thirteen, my brother Jem got his arm badly broken at the elbow..."(3)</p>	<p>This is an analytical reflection</p> <p>From what I can gather about Atticus so far, he seems well known and respected in the town of Maycomb. He is a lawyer, so I assume quite intelligent, and if everyone knows him or is related to him, the town must be really small. I think Atticus will play a large role in the book – perhaps his job as a lawyer will come into play? Although, it says Atticus was getting a "profound distaste for the practice of criminal law"(5). Hmm...maybe because of the hangings his clients got. I think this is foreshadowing events to come.</p>
<p>Atticus, the lawyer, "was Maycomb County born and bred, he knew his people, they knew him, and because of Simon Finch's industry, Atticus was related by blood or marriage to nearly every family in the town" (6).</p>	<p>This is a text-to-self connection</p> <p>Atticus is a well-known man in his town which reminds me of my Uncle Bob. Uncle Bob knows everybody in town and is sometimes referred to as "the mayor" even though he has no political connections. Uncle Bob is highly respected and people listen to his opinions. This makes me wonder why people did not listen to Atticus in <i>To Kill a Mockingbird</i>. If he was highly respected in the town shouldn't they have treated him better when he took Tom's case?</p>
